Judge John Gembic – Is looking for the City's Help with a work release program where inmates could come and help the city tear down properties at a cost of the dumpster, or they could rehab properties. Judge Gembic asked for the citys help with this. Judge Gembic stated some facts that he looked up at his office. From 2014-2016 Rick has 650 cases for the code office while Coal-Township has 205. In all those cases Judge Gembic has not found anyone not guilty. Code is doing a wonderful job here in the City of Shamokin.

Sharon Tlcozynski and Brenda Walsh- 24 S Franklin Street. Brenda's parents are afraid to stay in their home. They have people knocking on their door at all hours of the night. It smells like garbage and it is terrible to live there. Mr. Verano Stated that the code office an come over and look at the property tomorrow, and the mayor has asked the Police to do more patrols over in that area.
