Robert Derk – 110 Franklin Street – They are digging up the roads all over the 5^{th} ward. Is someone signing permits? If it is an emergency and a new service, they are not required to get a permit before they dig. City Council is working on a plan to change the ordinance on street digging. We need to stop the street sweeper until all the work is done in the 5^{th} ward. Someone could die over there if all these streets are closed and emergency vehicles could not get through.

Teresa Torres – Sunbury Street - There is heavy traffic on Sunbury Street and she would like to see about getting more speed limit signs. Council stated that this is a state route and PENDOT has to put in more signs. She said that the buttons on the cross walk on Sunbury Street are not working right. Council stated they will get them looked at.

Joseph Leschinskie – 518 E. Pine Street - During the Heritage Festival they had horse rides that went by Spurzheim and Rock Street. There are cars parked all over the sidewalks over there. They are tearing up the streets, there is steel slabs on the road, and the one had a six-seven-inch gap in it. What is the name of the business over on Rock and Spurzheim Street? We need to sink out teeth into these ordinances. We should get a salvage license and start towing these vehicles.
