The Following is the review Government Structure that the Home Rule Committee voted to pass from the partial draft.

**Article VIII** 

**Financial Management:** Treasurer will be included in the financial plan, the Council has the decision to call the hired qualified employee to do the duties a Treasurer. The employee must have an accounting degree and other qualifications to meet the laws of GASB. The Tax Collector position must be a qualified tax collector thru the State by completing a training and earning the credits by passing the State mandated test.

Submission of a balanced budget: The administrator and the Finance Committee shall prepare the proposed budget on or before June 30<sup>th</sup> each year. This budget can be changed and reviewed by Council until September 30<sup>th</sup>. Then the budget changes will be made and submitted for public review. The budget MAY provide estimates for a one- or two-year future expenditure and revenue to give the Council a better understanding of

what will be needed for the future, not just the new year. Council will publicize the budget. The budget will be

on display no less than 7 days or more than 14 after publicizing. Public special meetings will take place, NOT

on a regular council meeting date, this will ensure the public has input on the budget.

The year following a Municipal election the Council shall have the power to revise the budget and tax levies.

This must be done within 45 days of taking office and no later than February 15<sup>th</sup>. Semi-annually of the

calendar year the administrator and department heads shall appear before Council and review revenue and

expenditures at a public meeting.

A Term limit was agreed upon for Council members. No elected official can serve more than 3 terms. This
