The Regular Monthly Meeting of Shamokin City Council was held this evening with Mayor Richard Ulrich presiding.

CORRESPONDENCE:

CITIZENS COMMENTS (contingent upon business listed on the agenda):

Vinny Clausi thanked the Council members for their help with the fundraiser for the Ukrainian children. Almost \$11,000 was raised on the highway. The total amount raised was \$144,000 and they will go sometime this month. Mayor Ulrich thanked him for asking them to help out.

Chris Grego stated he was not here affiliated with reporting or the News Item, he was here as a citizen of Shamokin. He thanked the first responders and the Chief for the work on the case on Vine Street. He spoke about some things that concerned him regarding elections recently and the removal of a newly elected member of Council and why his name was allowed to be on the ballot if he was to be removed from office if elected. He brought up mail-in ballot information and postcards that a resident received in the mail encouraging voting by mail-in ballot. His three minutes were over. The Mayor asked if he went to the County Commissioners meeting where he could speak to them. He spoke to the Board and the Judge of Elections and they said only the County should be sending election ballots or information.

Jesse Storm with Brokers Realty requested they hold hearings for each ordinance so the public can hear and speak in regards to that. First of all, the trash can ordinance and he brought a 20-gallon trash can as an example. Most people in Shamokin use 36-, 40-, or 96-gallon trash cans for larger families. The trash can he brought with him would not meet code because of the leak-proof and waterproof because the manufacturer of the trash can put air holes on the bottom so when taking out the trash bag there's not a vacuum seal. He found 20-gallon trash cans online that are leak proof and waterproof. He is concerned about removing the trash cans people currently have and replacing them with smaller trash cans. He cited the ordinance and asked if the City would buy trash cans for every homeowner in Shamokin. Lastly, he requested a hearing about all the ordinances.

Brandy Finney spoke about the ordinance for the trash cans. She thinks there should be alternatives as well as what is already put in the ordinance. She has 8 people in her home and has two trash cans one 55-60 gallons and one 38 gallons with a lid that are in front of her home and are not impeding the sidewalk. She pays per trash can/bag and cited how costly that would be with the smaller trash cans. She is asking to put something else in there if they can find a way to

contain it in front of their home so its not unsightly. Councilman Roughton stated he spoke to everyone earlier and they did increase the size of the containers. He said it should be a solid container with a lid.

Jesse Storm stated if they have an ordinance they pass, they can't make special exceptions. He asks that they write it in the legislation and create the language so it fits the community. Solicitor Greco stated those are minor changes that were mentioned.

CITIZENS' COMMENTS:

Jesse Storm spoke about the issues he brought up about the ordinances passed and proposed under Title 65 under Pennsylvania Code, the second reading was done and they can't vote on these motions for three days from after the reading. He believes it is a violation of code. Secondly, the UCC Property Maintenance Code that was passed was not submitted to the state 30 days prior to the first reading, there are a lot of legal issues which is why he requested the hearings to be held so they can discuss it. He believes it is unenforceable. Council went to executive session for personnel matters and when they returned, the meeting was adjourned.
