Fire Department reported 34 total calls for the month of January 2023.

Code Office collected \$26,614.00 in revenue for the month of January 2023.

Councilman Milbrand mentioned Engine 11 is down and if the ARPA funds can cover that. Aaron replied that ARPA funds can cover that; they just need the vote from Council to approve the distribution of the funds. The RDA's apparatus is being housed at Station 30. The City Administrator stated he will let him know when they have a meeting with the RDA and the Shamokin Police about the situation with the space there.

SEDA-COG

Aaron asked about the fire hoses that were ordered. Councilman Milbrand stated they have not arrived yet. Aaron also mentioned the items that are on the agenda tonight that he spoked about at the work session.

Betsy spoke about her report. 118 people showed up to the reconvening meeting. She mentioned the Façade Grant. There are still two openings from the last round of funding and ten from the current round. Betsy mentioned the Safe Streets for All Grant, H&H Study, Volunteer Park and Footbridge Plan, Independence Street Downtown Makeover, the CFA Multimodal Grant, Illumination Station, the Comprehensive Plan and Zoning Book, the Brownfield Grant, and LERTA. She is working with Maggie on the EPA Swiffer Grant. She is also working to extend her time with the City and also to bring in a Downtown Manager.

Chief of Police

Police Department reported 1,187 total calls for January 2023.

The Chief mentioned he will be scheduling with the Civil Service Commission for the promotion test. He spoke about the applications for employment for Officers. He also spoke about defibrillators for public buildings and asked about that being done through ARPA. The only concern is the procurement process if it's over \$10,000. The Chief stated he has been discussing this with Councilwoman Moyer. They would need Council approval to allocate the money there and make sure the procurement requirements are followed.

Regarding agenda item #19, Councilwoman Annis stated the Sixth Street Bridge was included in the areas being closed and she had some concerns about that. The Chief said they could have 6th to 3rd and Market to 3rd, and traffic control at 6th with an early warning. Councilwoman Annis spoke with Sarah, she asked if they could have crossing guards on 6th and keep it open. The City Administrator stated it is different to have people in uniform doing traffic control rather than if they are going to be asking the general public. The Chief recommended that the Fire Police could do that since they are in uniform. Councilman Milbrand asked if there were going to be using the Independence Fire Company parking lot during the event. Sarah said that depends on how many vendors they have but ideally yes. The consensus was to allow them to close Market to one side of 6th and 6th to 3rd as long as they reach out to Fire Police and utilize Fire Police as recommended by the Chief of Police.

He mentioned 500-502 Bear Valley Avenue which they've taken 19 and ½ tons of trash out of the six car garage and the basement. They are in the process of putting new doors on the building and renovating the building, hoping to have the occupiable area renovated within the month and then move on to the outside structures like the porches and balconies and refinishing the property. Code identified the property and Mr. Storm is expecting \$600k spent on the building until it's within legal code again. He also mentioned the situation that occurred recently with charges for a City employee and if there is some issue with money that has transpired that they look at dealing with it until there's an outcome and what they need to do to protect the City of Shamokin.
