# CITY OF SHAMOKIN

## Restricted Parking Sign Application

- A. The City of Shamokin will promulgate and have available applications for restricted parking signs. Said applications can be obtained at City Hall. A \$10.00 processing fee is required. This fee is non-refundable.
- B. Disabled applicants seeking a restricted parking sign must possess a handicap plate, handicapped placard or severely disabled veteran registration plate, valid PA drivers license and vehicle registration in order to obtain an application for approval.
- C. Disabled applicants must submit a written statement from his or her physician describing the disability at the time of the application, including the anticipated duration of the disability.
- D. Disabled applicants may be required to attend an independent medical evaluation performed by a physician of the City's choice to verify the disabled status of the applicant.
- E. Applications are to be completed in their entirety. Applications not completed in their entirety will not be considered and must resubmit along with another \$10.00 processing fee.
- F. Applicants with available or acquired off-street parking, car ports, garages, approved driveways, etc. may not be considered for a restricted parking sign.
- G. Approval or denial of the applications will be made within ninety (90) days by the issuing authority.
- H. Upon approval, the City of Shamokin will erect no more than one (1) restricted parking signs for individuals with the appropriate VIN. In addition to that, the approved applicant shall pay \$50.00 for the cost of each restricted parking sign, bolts, and pole. The City will waive all labor fees.
- I. Each year the applicant shall submit a \$100.00 fee in order for the Code Enforcement Office to continually verify the applicant's status and/or need for a restricted parking sign. Although courtesy notices may be sent to each restricted parking sign holder reminding him or her of the January 31<sup>st</sup> deadline it is the holder himself or herself who is solely responsible for making payment in full on or before the deadline of January 31<sup>st</sup>, for each calendar year. Nonpayment of the annual fee will result in removal of the restricted parking sign.
- J. The Street Department is hereby authorized for the marking of restricted marking spaces as described in 103-10, and it shall be

unlawful to park any vehicle in such a way that said vehicle shall not be entirely within the limits of the space so designated.

- K. Any person who violates or abuses any provision as set forth in this resolution will be warned for the first offense and then lose the restricted parking privilege for a second offense. The violator will not be able to reapply for a restricted parking privilege for one (1) year thereafter and will have to pay all processing and material costs. Furthermore, it shall be deemed an abuse of privilege when a person granted a restricted parking sign does not utilize the restricted parking space in the manner in which it was intended for.
