Mayor Milbrand asked City Clerk Robert Slaby if he could catch us up on the 2013 bills. Mr. Slaby told Mayor and Council that we received the loan from DCED and he has been paying certain accounts that were in jeopardy of going into collections. It has been a slow and tedious process, I need to contact each creditor to discuss bill. 80% of the creditors have agreed to waive late charges or interest charges. For example one of the business owners that I have talked with gave a deduction from 169,000 down to 132,000 just by talking and explaining our situation. With the lack of staff, and still managing the 2014 bills were doing OK. The bills did not happen overnight and I cannot pay them overnight but we are making progress.
